## **WHAT THEY ARE SAYING: Governor Ron DeSantis Remains Committed to Lowering Prescription Drug Prices for Floridians**

**TALLAHASSEE, Fla.** – Last week, [Governor Ron DeSantis announced several actions to lower prescription drug prices for Floridians](#). The Governor issued [Executive Order 22-164](#) to provide meaningful reforms to state agency contracts with Pharmacy Benefit Managers (PBMs), and direct the Agency for Health Care Administration (Agency) to implement provisions in the Freedom First Budget and directly negotiate prices for prescriptions drugs ineligible for importation, including insulin and epinephrine.

Additionally, the Agency [filed a Freedom of Information Act Request \(FOIA\)](#) with the U.S. Food and Drug Administration (FDA) regarding the status of their review of Florida's landmark Canadian Drug Importation Program. Community leaders have recognized these actions to continue increasing transparency and accountability within Florida's pharmaceutical industry.

### ***Here is what they are saying...***

"Thank you to Governor DeSantis for continuing to push for Federal approval of Florida's Canadian Prescription Drug Importation program by filing a FOIA request to the U.S. Food & Drug Administration, ensuring continued transparency in their review process," said **Senate President Pro Tempore Aaron Bean**. "In addition to this welcomed news, the 2022-23 State Budget provides additional authority for AHCA to directly negotiate prices for prescription drugs ineligible for importation – like insulin and epinephrine. I am proud to have sponsored both initiatives during my time in the Senate that disrupt the status quo and lower the cost of prescription drugs that so many Floridians rely upon."

"In 2019, I was honored to join Governor DeSantis in passing landmark legislation that would safely and directly reduce the cost of prescription drugs," said **Representative Tom Leek**. "On the 99-yard line of success, the Biden administration inserted itself into the process and used the FDA to stall the approval of this program, taking the side of Big Pharma and profits over taxpayers. Biden's pro-establishment policies do nothing but hurt Americans, and this is a great example."

"Florida pharmacies are thankful to the DeSantis Administration for protecting the health of our patients in the community and taking actions to keep drug costs affordable, said **Ben Levene, Owner, Center Pharmacy in Cape Coral**. "In helping to create a fair and competitive environment and access to quality healthcare, Governor DeSantis is ensuring we can help lower costs for our patients and the health plan payers."



"The National Association of Chain Drug Stores appreciates Governor DeSantis' action to put patients first and to stand up for the pharmacies that serve them," said **Steven C. "By taking on these tactics of PBMs, Governor DeSantis is exerting true leadership to defend healthcare access and affordability. DeSantis for recognizing that it doesn't have to be this way and are eager partners in working to investigate, rein in, and reform the massive PBMs and their insurer-partners/owners."

"With this Executive Order, the governor will shine the light on anticompetitive behavior and require much needed transparency in what is now an opaque process.
