## Medicaid Coverage of Coronavirus Laboratory Testing Update: New Procedure Codes and Rapid Testing

The Agency for Health Care Administration (Agency) is committed to ensuring that Medicaid recipients diagnosed with the 2019 novel coronavirus (COVID-19) receive all the care needed to address their symptoms. **Florida Medicaid covers and will cover all medically necessary services required to facilitate testing and treatment of COVID-19.** The purpose of this alert is to provide Florida Medicaid coverage updates of laboratory testing for COVID-19.

### Laboratory Test Coverage

Florida Medicaid covers testing for COVID-19 consistent with the guidelines established by the Centers for Disease Control and Prevention (CDC) and the Centers for Medicare and Medicaid (CMS).

### Expansion of Laboratory Procedure Codes

CMS and the American Medical Association (AMA) recently established procedure codes to identify new modalities and methods of COVID-19 laboratory testing. This table details Florida Medicaid's coverage of COVID-19 laboratory testing, categorized by the type of test and detection method.

Other rapid testing	Antibody testing	86328	\$10.21	On or after 4/10/20

Additional information is detailed below:

- These services are covered as detailed in the AMA's Current Procedural Terminology (CPT) code book and as defined by CMS.
- Florida Medicaid will cover the newly established laboratory codes consistent with the [CDC guidelines](#). Coverage dates in the table align with the procedure code establishment dates by CMS and the AMA.
- **Providers cannot use U0001-U0004 or 87635 for antibody testing.**
- Providers should work with Medicaid health plans to determine the reimbursement rates for these procedure codes for Medicaid recipients enrolled in plans.

#### Practitioner Laboratory Coverage

The reimbursement rates for practitioner laboratories that are CLIA certified and can safely and accurately perform any of the COVID-19 laboratory tests described in this alert are as follows:
